We process all data processed for accounting and tax purposes for 5 years counted from the end of the calendar year in which the tax obligation arose.

GDPR /the name in Poland is **RODO**/—Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC; **Accounting Act** — the Accounting Act of 29 September 1994 (i.e. Journal of Laws of 2018, item 395, as amended).

4. Your personal data will be made available to recipients, including:

- a) entities cooperating with the Data Controller,
- b) providers of ICT services, courier service providers, entities acting as intermediaries in the sale of our services or in the organization of our marketing campaigns, entities providing us legal assistance and advisory and auditing services, entities conducting payment activities (banks, financial institutions).

5. You have the right to request the Data Controller:

- a) to provide you with access to your personal data,
- b) to rectify your personal data,
- c) to delete your personal data (a request to delete your personal data will result in the immediate deletion of your personal data from our database),
- d) to restrict the processing of personal data,
- e) to lodge a complaint with the supervisory authority,
- f) to transfer your personal data,
- g) to withdraw consent to the processing of personal data at any time. The withdrawal of consent will not affect the lawfulness of processing carried out on the basis of the consent prior to its withdrawal, but will prevent us from providing services,
- h) objecting to the processing of personal data where the processing is necessary for the performance of a task carried out in the public interest or subject to the exercise of official authority entrusted to the Data Controller and where the processing is necessary for the purposes of the legitimate interests pursued by the Data Controller or by a third party, including profiling. The Data Controller is no longer allowed to process such personal data unless it demonstrates that there are compelling legitimate grounds for processing overriding the interests, rights and freedoms of the data subject or for establishing, exercising or defending a claim.
